Ran 347 jts 2 3/8" tubing, set SN at 10,928'. ND BOP, NU tree. Swab tested. RD Key Energy unit. Swab tested.
Opened to sales line 3-15-2006; well loaded up the next day. Ran swab and resumed flowing. RD unit. FTP 100 psi, CP 600 psi, 21/64"choke, 46 BWPD, 262 MCFGD, in 24 hrs.
