2/4/06 TD 12-1/4" hole at 12:00 PM. Set 9-5/8" 36# J-55 8rd ST&C casing at 1757'. Cemented with 525 sx Premium Plus-SBM + 2% CaCl + 1/4#/sx Flocele (yld 1.98, wt 12.5). Tailed in with 200 sx Premium Plus Class "C" Type III + 2% CaCl (yld 1.35, wt 14.8). Cement circulated to surface. Tested casing to 1500 psi for 30 min. WOC 40 hrs 50 min. Reduced hole to 8-3/4" and resumed drilling. NOTE: Hole reduced to 8-3/4" on previous sundry was incorrect, should have been 12-1/4".
