RIH & set 8-5/8" 24# J-55 BTC csg @ 403', pump 20bbl gel spacer w/ red dye followed by 200sx (48bbl) PPC w/ 2% CaCl2, 14.8ppg, 1.34 yield, had full returns, circ 62sx (15bbl) cmt to surface, WOC. 5/11/14, install WH, test to 960#, test passed. RU BOP, test @ 250# low 3000# high, good test.

RIH & tag cmt @ 350', test csg to 2065# for 30min, test passed. POOH, casing seem to have parted, SI WO evaluation. RIH w/ WL casing inspection log, casing parted 18' below GL.

Received BLM approval 5/13/14 to plug this wellbore and skid rig. ND BOP, cutoff WH, RIH w/ DP, pump 10bbl gel spacer w/ red dye, followed by 100sx PPC (24bbl), 14.8ppg, 1.33 yield, circ 20sx (5bbl) cmt to surface. RR 5/14/14.
