Drilled 7-7/8" hole to TD4521' on 8/17/14. Ran open hole logs. On 8/18/14, set 5-1/2" 17# J-55 production csg @ 4513'. Cmted w/lead 200 sx (381 cf) 35:65 poz "C" cmt w/5% salt, 0.25# CF, 5# LCM1, 0.2% R-3, & 6% gel. Tailed w/715 sx (951 cf) cl "C" cmt w/6% R-3 & 0.25# CF. Circ 141 sx cmt to pit. Released drilling rig on 8/19/14. Plan to pressure test 5-1/2" csg during completion operations.
