

Corners rounded off to gain more in reclamation since these areas are not used for daily operations. Extra reclamation was completed on the east to make up for loss of some acreage to the north due to new pipeline installation ROW. It didn't make sense to reclaim this area. Reclaimed area was moved to the south and east to close out some pasture. This was also the deepest area of cut that needed to be backfilled with material taken from the west.

Remaining surface needed for daily operations is 230' x 150' (includes 14' road running through well pad) or 0.79 acres.

Other information: well pad clean of spills, pump jack shale green, and secondary containment netted.
