Comments on Inspection: Well head needs to be cut off & P/A marker installed no later than June 12, 2009, violation of 19.15.25 [NMAC]

It was noted during physical inspection that the deadman anchors have not been removed and location clean-up not done.

The violations shown during the above 4/16/09 inspection were corrected on 5/19/09. This included clean-up, removing the anchors, cutting off the wellhead and installing the P/A marker.
