10/03/14: We set a CIBP # 9780 w/2 sx cm) on top w/TOC @ 9763'.

11/21/14: Ran 4" liner from Surface to 9737' inside of 5 1/2" casing w/DV tool @ 5570'. Circ & cmt liner in place w/lead 445 sx Class C and tailed w/220 sx Class C.

12/16/14: We perfed the well from 9420' - 9480'. Fraced w/1,685 gals water and 74,124# sand.

01/08/15: After frac, we pulled the packer and ran production tubing to 9347' and put the well on rod pump.
