2/2/16 - Unseated pump. NU BOP. RIH with GR/JB to 3250 ft.  
2/3/16 - Set a 5-1/2 inch CIBP at 3240 ft. Tagged CIBP. Spotted 25 sx Class C Neat cement on top of CIBP. Calc TOC 2987 ft. Spotted 25 sx Class C Neat cement at 2650 ft. Calc TOC 2397 ft. Perforated 4 holes at 2186 ft. Pumped into perms, pumped 60 sx Class C Neat cement. Displaced to 2086 ft. WOC.  
2/4/16 - Tagged plug at 2030 ft. Isolated bottom of holes in casing at 474 ft. Pumped 310 sx cement at 474 ft and circulated to surface. ND BOP. Topped out casing. Witnessed by BLM.  
2/10/16 - Dug out cellar and cut off wellhead. Installed dry hole marker. WELL IS PLUGGED AND ABANDONED.
