Cimarex respectfully requests approval to shut-in production for EDDY 21 FEDERAL COM 1 well due to pipeline maintenance and pipeline section replacements of the Transwestern Pipeline. Transwestern anticipates the maintenance project to be completed by January 1, 2017. Cimarex is reviewing other delivery point options with DCP. Other delivery point routes may require DOT compliance work which could take several months to complete. When an alternate route is determined and wells are returned to production, a sundry will be submitted for approval.
