ConocoPhillips respectfully requests to enlarge the Golden Spur Facility 150' to the North making the facility pad a total of 450' x 250'. ConocoPhillips would also like to re-route the pipeline that extended from the Red Hills West B Compressor. The pipeline will no longer go from the compressor to the tie in point at the Nuevo pipeline, instead the pipeline that ties into Nuevo will follow the road and enter at the south of the facility. There will be 198' of pipeline on BLM land and 1746' on private land totaling 1944' of pipeline. Attached is the preliminary plot plan for the facility expansion and plats for the pipeline re-route.
