MIRUPU. POOH w/rods and tubing. Run 5 1/2" CBP on wireline & set at 2240'. Perforate 5 1/2" casing 2188'-90' with 8 holes. Break circ down 5 1/2" casing and out 5 1/2" x 8 5/8" annulus to surface. Pumped 210 bbls FW at 2.5 BPM and 300 psi. GIH with cement retainer on tbg. Set cement retainer at 2131'. Cement thru holes in 5 1/2" casing at 2188'-90 with 360 sxs Class C with 1% CaCl. Cement wt 14.8#/gal. Yield 1.32, 85 bbls cement. Good circ, but cement did not circ to surface. POOH with tubing and setting tool. Run CBL and found TOC at 700'. Got OK from Kenneth Rennick to cement down 5 1/2" x 8 5/8" annulus. Establish rate 2.5 BPM at 100 psi using fresh water. Pump 120 sxs Class "C" with 1/4# celloflake, wt 14.8#/gal, yield 1.34 cu ft/sx. Shut down on strong vacuum. Call for more cement. Pumped 125 sxs Class "C" with 1/4# celloflake, wt 14.8#/gal, yield 1.34 cu ft/sx down 8 5/8" x 5 1/2" annulus and locked up at 200 psi. Annulus full. Drill out cement retainer at 2133' and cement inside 5 1/2" casing. Ready to deepen well.
