5/13-15/16 - Set a 7" CIBP at 7550'. Tagged CIBP and loaded hole with 270 bbls fresh water. Tested casing to 500 psi. Spotted 25 sx Class "C" cement. Calc TOC 7398'. WOC.

5/16/16 - Tagged plug at 7400'. Spotted 45 sx Class "C" cement at 6000'. Calc TOC 5725'. WOC 4 hrs. Tagged at 5724'. Spotted 35 sx Class "C" cement at 3627'. Calc TOC 3418'. Spotted 35 sx Class "C" cement at 2265'. Calc TOC 2056'. Spotted 40 sx Class "C" cement at 1132'. Calc TOC 923'.
