We are flaring for our newly drilled wells as of 7/1/15 and approx. We are in the process of setting up compressor to send the gas to sales, but DCP has issues setting the line so we are flaring approx. 2500 mcf/d until we DCP resolves their issue and we can continue compressor tie in.

DCP resolved their issue Friday, 8/14/15, and we were able to tie in compressor yesterday, 8/16/15. Total flared 1128 hours and 89,618.
