The wellhead had a gauge malfunction, causing the Bordon tube to fail.

An approximate area of 35' X 40' was affected around the wellhead on the production pad. Vertical and horizontal delineation samples were taken and analysis ran for TPH & BTEX. TPH & BTEX are under RRAL's (site ranking is 10) an Initial/Final Report, C-141 is submitted to the OCD requesting closure. Depth to Ground Water: 50-99' (approximately 80', Section 13, T17S-R28E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 10. Yates Petroleum Corporation requests closure.
