6/24-26/16 - RIH with 5-1/2 inch HM plug, had tight spot at 1400 ft. Set down at 1424 ft, dragging coming up. Pulled through tight spot and TOOH. Removed CIBP. Tagged at 2250 ft. Mixed and pumped 150 sx Class C cement. Calc TOC 805 ft. WOC.

6/27/16 - Tagged plug at 1435 ft, BLM ok'd. Pumped 160 sx Class C cement at 1435 ft, circulated to surface. Topped out casing.

7/5/16 - Dug out cellar and cut off wellhead. Installed dry hole marker and filled cellar. WELL IS PLUGGED AND ABANDONED.
