6/1/16 - NU BOP.

6/2/16 - Pumped 100 bbls brine. Spotted 40 sx Class H cement at 8145 ft. Calc TOC 7931 ft.

6/3-5/16 - Tagged plug at 7647 ft. Loaded hole with 270 bbls. Tested casing to 500 psi. Asked BLM about spotting cement plug on top instead of setting CIBP, BLM ok'd. Spotted 25 sx Class H cement at 7600 ft. Calc TOC 7466 ft. WOC.

6/6/16 - No pressure on well. Tagged at 7400 ft. Loaded hole with 40 sx mud gel and 170 bbls brine. Spotted 35 sx Class H cement at 6286 ft across Wolfcamp top up to 6094 ft. Spotted 35 sx Class H cement at 6000 ft across stage tool up to 5816 ft. WOC. Tagged cement top at 5816 ft.

6/7/16 - Spotted 30 Class C cement at 3540 ft across Bone Spring top. TOC approx 3356 ft. Spotted 30 sx Class C cement at 2296 ft across Glorieta top. TOC approx 2112 ft. Spotted 35 sx Class C
