4/29/16 - Tagged plug at 4970 ft. Spotted 25 sx Class C cement as per BLM. Calc TOC 4721 ft. No tag as per BLM rep Joe Salcido. Perforated 4 shots at 3378 ft. Pressured casing to 500 psi, good. Spotted 35 sx Class C cement at 3428 ft. Calc TOC 3074 ft. WOC.

5/2/16 - Tagged plug at 3145 ft, BLM ok'd. Perforated 4 holes at 2155 ft. Set pump thru perfs circulated out 9-5/8 inch x 5-1/2 inch, pumped 50 sx Class C cement. Displaced TOC to 1985 ft. WOC.

5/3/16 - Tagged plug at 1926 ft. ND BOP. Perforated 4 holes at 450 ft. Pumped thru perms circulated out 9-5/8 inch x 5-1/2", mix and pumped 150 sx Class C cement and circulated to surface. BLM ok'd cement at surface.
5/9/16 - Dug out cellar, cut off wellhead and installed dry hole marker. Filled cellar. WELL IS PLUGGED AND ABANDONED.
