

Gentlemen:

Pursuant to your letter of December 31, 2015, this office concurs with your determination that the Poker Lake Unit CVX JV BS #023H completion is not capable of producing unitized substances in paying quantities.

This well's Bone Spring Second (2) Shale completion is therefore not entitled to be part of a Participating Area and production from this formation should be reported on a lease basis, however since this is a horizontal well crossing from State to Federal, a Communitization Agreement is required. Also, a Sundry shall be submitted to drop "Unit" from well name and add "Com" to the name. Our concurrence is subject to like concurrence by the State Commissioner of Public Lands.

Under provisions of 43 CFR 3165.3, you may request a State Director Review of the decision described above. Such a request, including all supporting documents, must be filed in writing within 20 business days of receipt of this notice and must be filed with the State Director, Bureau of Land Management, P.O. Box 27115, Santa Fe, New Mexico 87502-0115. Such request shall not result in a suspension of the order unless the reviewing official so determines. Procedures governing appeals form instructions, orders, or decisions are contained in 43 CFR 2175.4 and 43 CFR Part 4.
