

Corrosion of a nipple on the water transfer line caused a 238 bbls leak of produced water. A vacuum truck recovered 120 bbls and the nipple was replaced.

Describe Area Affected and Cleanup Action Taken.*

The affected area is approximately 100' x 50' with most of the leak staying on location. Remediation will be completed in accordance with an approved remediation plan from NMOCDC and the BLM.
