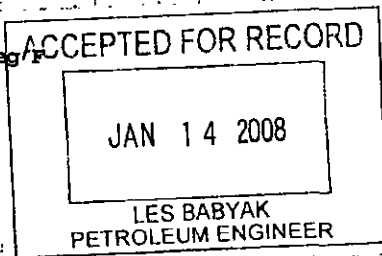

1. Cemented w/ 600 sx POZ C, 11.8 ppg, 2.45 yield; 200 sx Prem Plus C, 14.8 ppg, 1.34 yield.
Circulated 275 sx to surface. WOC 13.5 hrs.
2. Approximate temperature of cement when mixed - 75 deg F
3. Estimated minimum formation temperature in zone of interest - 107.67 deg F
4. Estimated cement strength at time of casing test - 820 psi
5. Actual time cement in place prior to starting test - 13.5 hrs.
