

AREAS TO BE RECLAIMED WILL BE RECONTOURED TO MATCH SURROUNDING AREAS, THE TOPSOIL WILL BE DISTRIBUTED ACROSS ALL RECLAIMED AREAS, RIPPED ACROSS ANY SLOPED AREAS, AND SEEDED WITH BLM LPC SEED MIXTURE. WELL PAD WILL BE BERMED TO PREVENT CONTAMINANTS FROM LEAVING LOCATION IF AN UNDESIREABLE EVENT WAS TO OCCUR.
