9/7/16 – ND wellhead and NU BOP. Pumped 30 bbls fresh water down tubing. Released packer. RIH with GR/JB to 5670'. Set a 5-1/2" CIBP at 5660'. Tagged CIBP. Loaded hole with 6 bbls. Tested casing to 500 psi. Spotted 25 sx Class "C" cement. WOC.
9/8/16 – Tagged plug at 5406'. Spotted 25 sx Class "C" cement at 5099'. Calc TOC 4853'. Spotted 25 sx Class "C" cement at 4418'. Calc TOC 4172'. Spotted 25 sx Class "C" cement at 2102'. Calc TOC 1856'. Perforated 4 shots at 600'. RIH to 400'. Pumped into perfs 1.5 BPM. No circulation. Pumped 25 sx Class "C" cement with 2% CaCl. Pressured to 200 psi. WOC. Tagged at 480'. ND BOP. RIH to 96'. Filled 5-1/2" with cement to surface.
9/13/16 – Dug out cellar and cut off wellhead. Installed dry hole marker and filled cellar. **WELL IS PLUGGED AND ABANDONED.**
