Tested casing to 500 psi. Spotted 25 sx Class C cement on top of CIBP. Calc TOC 4126 ft. Spotted 30 sx Class C cement at 2164 ft. Calc TOC 1868 ft. WOC.
9/12/16 - Tagged plug at 1830 ft. Spotted 30 sx Class C cement at 1186 ft. WOC. Tagged at 928 ft. ND BOP. RIH with tubing to 96 ft. Filled 5-1/2 inch to surface with cement.
9/13/16 - Dug out cellar and cut off wellhead. Installed dry hole marker. WELL IS PLUGGED AND ABANDONED.
