Yates Petroleum Corporation plans to plug and abandon this well as follows:

- MIRU all safety equipment as needed. NU BOP. TOH with production equipment. Make a GRUB run to 7020'. Set a 5-1/2" CIBP at 7010' then dump 35' Class "H" cement on top of CIBP. - WOC + TAG
- Load hole with plugging mud. Spot 25 sx Class "C" cement plug from 5485'-5335', this will cover top of Cherry Canyon. - WOC + TAG
- Spot 25 sx Class "C" cement plug from 4540'-4315', this will cover top of Bell Canyon & DV tool. - WOC + TAG
- Spot 25 sx Class "C" cement plug from 4290'-4150', this will cover 8-5/8" casing shoe. WOC and tag. ← PERF + SQUEEZE
- Spot a continuous 330 sx Class "C" cement plug from 4125'-700', this will cover the entire salt section and 13-3/8" casing shoe. WOC and tag.
- Spot a Class "C" cement plug from 50' up to surface: PERF @ 868' ± SQ
- Cut off wellhead, install dry hole marker and clean location. WOC + TAG




