Plug down @ 10:30 P.M. 02/05/16. Circ 75 sks cement to pit. WOC. Tested BOPE to 5000# & Annular to 3500#. Tested standpipe & mud lines to the pumps to 5000#. At 4:00 A.M. 02/07/17, tested csg to BOPE to 1500# for 30 minutes, held OK. Drilled out with 12 1/4" bit.
