We are requesting approval to install an electrical power distribution system from the XCEL take off point in the NE/NE quarter of Section 24 and to follow the route to the Sandy Federal #1. Please see attached diagram.

The proposed primary power line will consist of 7436' of new overhead power line operating at 12,470 volts to provide power to the Sandy oil wells. The powerline will only be used for Strata Production Company wells. It is a distribution powerline not a transmission system. It will be consist of 28 40' class 5 wood poles spaced evenly through out the project, each with a 8' wood crossarm, 60" crossarm braces, 1/0 ACSR conductor with no neutral and 4 320 amp 3 phase meter bases. No substations or other ancillary facilities are involved. The project will be constructed after the completion of the proposed system that Cimarex is constructing in the same right of way.

32. Additional remarks, continued

Due to the sandy nature of the right of way, some minor dirt work will be necessary to get the trucks in to install the poles.

The project will commence at the North east corner of Section 24-T23S-R30E at the XCEL powerline that has been constructed.

The powerline will be extended to the south and west and will terminate at the existing STRATA power system at the Sandy FED #1, which is located 660' FWL & 1980 FNL in Section 24.

The project will be constructed by OTI Electrical Services from Andrews, Texas and will be built to ASME standards. The entire project is contained to Section 24 which is entirely on Federal Lands. No other Federal or State agencies are involved.

The project will commence after the construction of the Cimarex powerline and should take 14 working days, weather dependent. It is anticipated that construction will commence in early 2017.

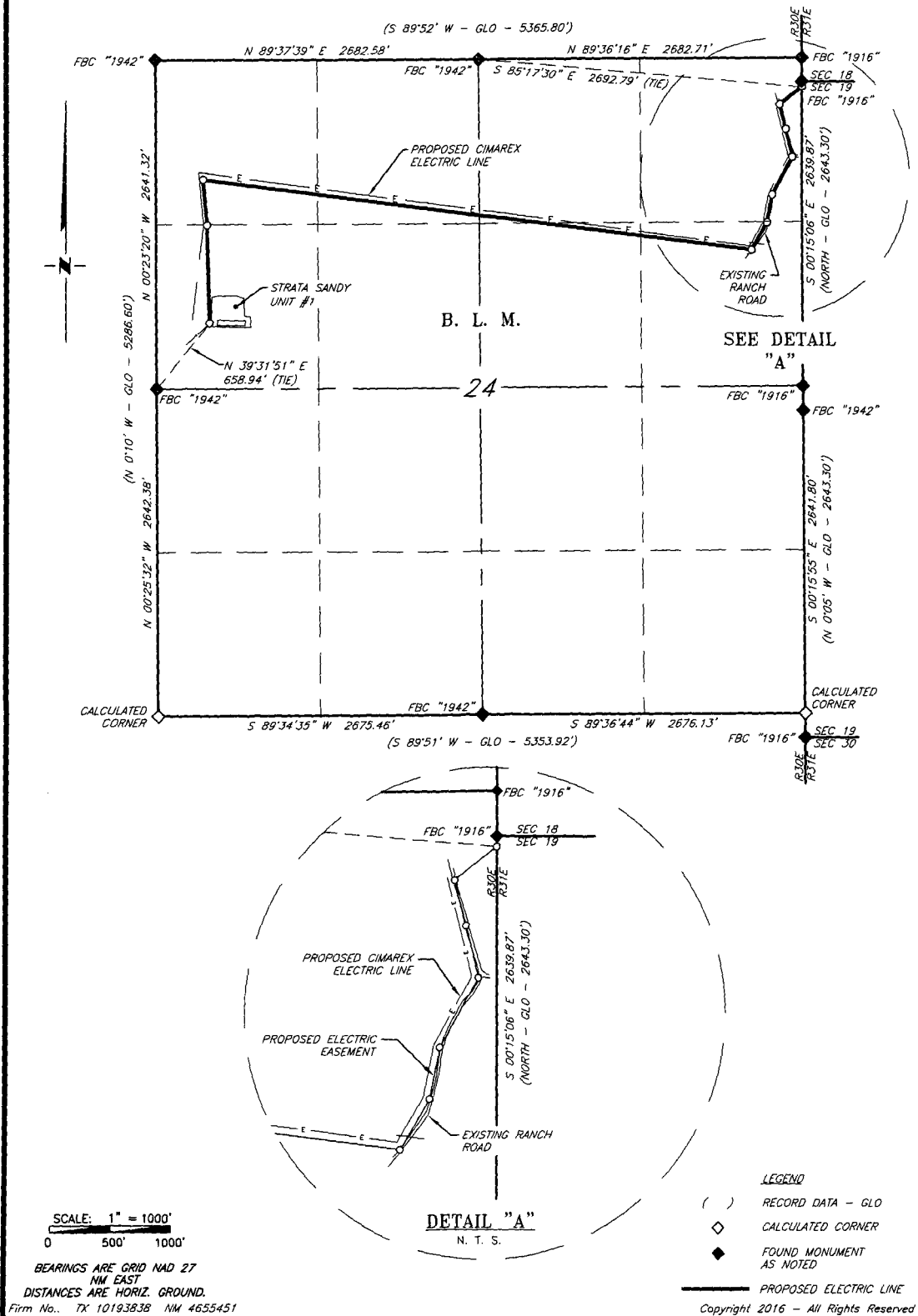
The project has been surveyed and flagged and there is adequate access to the area using the existing 2 track roads. Due to the sandy nature of the area, no seeding or revegetation will take place as the existing vegetation will cover the disturbed area.

Project life span is 10 to 20 years. After the wells are plugged and abandoned, all of this structure will be removed.
