If you do not comply, the Bureau of Land Management may take Action to be Completed By you shall be held responsible for compliance (NCR) in accordance with 43 CFR 31.13. For compliance, you must submit a written report of compliance as outlined in 43 CFR 31.13.1. The Bureau of Land Management may take Action to be Completed By you shall be held responsible for compliance (NCR) in accordance with 43 CFR 31.13.2. All self-certified corrections must be submitted no later than the business day after the prescribed time for compliance.
