These lines will be for temporary use and will not be used for more than 30 days.

This route does not cross any lease lines.

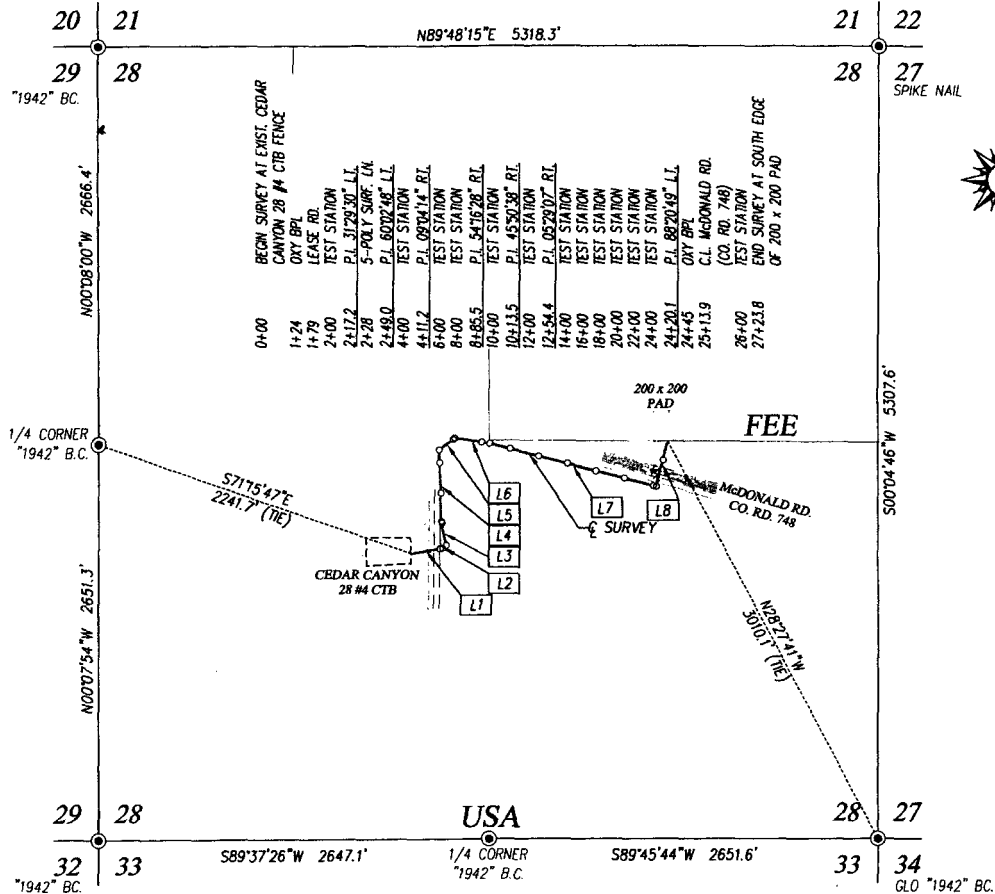

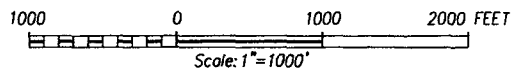
