12/15/16 to 12/29/16 RU WSU. POOH w/tubing and packer. Found 5 holes in collars throughout tubing. RIH w/new tubing. Set packer at 5207'. Annulus wouldn't pressure test. POOH w/tubing and packer. RIH w/RBP and set at 5202'. PU packer and RIH. Found hole between 5102-5130'. Work string. RIH w/pump out plug, packer with On/Off tool and tubing to 5050'. Circulate inhibited packer fluid inside and outside tubing. Load and test backside to 500# for 15 mins. Good test. Ran 30-min chart to 500#. Pump out plug still on packer. Injection zone and casing leak are isolated beneath the packer. Top of casing leak is 148' above top of injection zone at 5250'. We plan to plug and abandon well. Plugging contractor will submit sundry notice with plugging plan.
