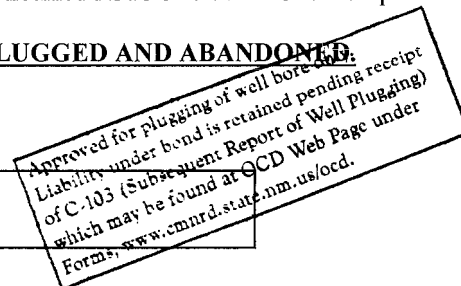

5/2/17 – MIRU. Loaded tubing with water. Pressure tested to 500 psi, test held. Released pressure.  
 5/3/17 – NU BOP. Set a 7" CIBP at 7573', tagged CIBP.  
 5/4/17 – Ran Gyro survey from surface to 7550'. Loaded and circulated well with plugging mud. Pressure tested CIBP and 7" casing from 7573' to surface to 500 psi, test held. Released pressure. Spotted 25 sx Class "H" cement from 7573'-7453'.  
 5/5/17 – Did not tag TOC. POOH with tubing, tubing string wet. Perforated drain hole above cement in tubing. Laid down bottom 24 jts tubing with cement. Set EOT above CIBP at 7573'. Pumped 30 bbls 10# plugging mud down tubing. Spotted 25 sx Class "H" cement from 7573'-7453'.  
 5/8/17 – Tagged TOC at 7513', notified NMOCD. Spotted 30 sx Class "C" cement at 6168'. WOC. Tagged TOC at 6159', notified NMOCD. Spotted 25 sx Class "C" cement at 5342' calc TOC. Spotted 30 sx Class "C" cement at 3317' calc TOC.  
 5/9/17 – Spotted 30 sx Class "C" cement at 1970'. Perforated 7" casing at 1175'. Loaded hole. Attempted injection. Pressured up to 500 psi, no rate. Spotted 35 sx Class "C" cement at 1016'. WOC. Tagged TOC at 1008', notified NMOCD. ND BOP. Pumped cement 65' to surface. Topped off wellhead with cement.  
 5/10/17 – Cut off wellhead and installed dry hole marker. Backfilled cellar. **WELL IS PLUGGED AND ABANDONED.**
