6/29/17 – MIRU. Pumped 20 bbls water down casing to kill well. ND wellhead and NU BOP. Set a 4-1/2" CIBP at 1250'. Pressure tested to 500 psi to surface, held good. ND BOP. Tagged CIBP at 1250'. Spotted 115 sx Class "C" cement from 1250' up to surface. Topped off casing with cement.

7/7/17 – Cut off wellhead. Install dry hole marker. **WELL IS PLUGGED AND ABANDONED.**
