systems experience periodic upsets due to gathering system pressure changes, freezing conditions or other normal variations. These upsets require intervention to return the plunger to surface and unload fluid from the wellbore. Possible options for this intervention include the use of a slick line unit to fish the plunger, a swab rig or coil tubing rig to remove liquid from the tubing, a service rig to pull the tubing or manual venting to reduce the wellhead pressure. Manual venting of the wells with an operator on site was chosen due to the elevated risk levels and increased cost of the other methods.
