Lime Rock proposes to set the 8-5/8" surface protection casing at a minimum of 1230', which is at least 50' below the base of the Artesian aquifer porosity that develops from 1160 to 1170' on the Lime Rock - Terry 14C #2 Neutron-Density log dated September 8, 2016. Historically there are at least 20 nearby Atoka field San Andres wells as identified in the IHS Energy database. Eleven wells have the surface casing protection string set at 1100' or deeper, with the deepest string at 1209'.
