5/17/17 - MIRU. Tubing on slight vacuum. Casing had no pressure. Pumped 50 bbls brine down casing. Tubing and casing on vacuum. NU BOP.
 5/18/17 - Released packer. Found hole in tubing. Hung up in DV tool at 8900 ft, Pulled 15 pts over and came free. Had a drag from 4333 ft - 4340 ft.
 5/19/17 - Reamed through tight spot from 3950 ft - 4400 ft. Reamed through DV tool at 8900 ft.
 5/22/17 - ND BOP. Circulated 200 bbls packer fluid at 2.5 BPM. No pressure. Pressure tested casing to 550 psi. Pressure increased to 620 psi due to packer fluid.
 5/23/17 - Pressured to 500 psi for 30 min, good. 2-7/8 inch tubing and AS1-X nickel plated packer 10,185 ft.
