Tail w/400 sks Class H w/additives. Mixed @ 15.6#/g w/ 1.18 yd. Displaced w/399 bbls mud. Plug down @ 2:30 PM 08/24/17. Set ECP w/3700#. Tested csg to 7500#. Drop bomb & open DV tool w/790#. Circ 227 sks of cmt off of DV tool to the pits. Cmt 2nd stage w/230 sks Class C Neat. Mixed @ 14.8#/g w/1.32 yd. Displaced w/132 bbls mud. Plug down 4:30 P.M. 08/24/17. Did not circ cmt.
