Marathon Oil Permian LLC. respectfully requests to drill this well using three casing strings plus a production string rather than three casing strings as per original permit. In order to safely drill pilot hole to plan depth 10,800 ft (TVD) a 7" casing string (Intermediate II) was added to the well design. 6 1/8" production hole will be drilled and a 4.5" liner will be run in the lateral. See changes listed below.
