Spotted 45 sx Class "C" cement on top of CIBP from 2486'-1835' calc TOC. WOC. Tagged TOC at 1760'. ND BOP. Spotted 80 sx Class "C" cement from 1120' and circulated up to surface. Topped off with cement.
