Cement level static at ground level while displacing cement & then cement level slowly dropped to ~30' below ground level. 8/28/17 Contact BLM Rep Gabriel Beneway & reported cement results & seek guidance. BLM gave verbal approval to do either a top out job or ready mix fill. RIH w/ 1" tag for cmt top job, tag cmt @ 40', cmt w/ 97sx (22bbl) 14.8ppg, 1.35 yield, cmt to surface.
