BLM inspection found oil inventories in the field at the Phillips KN Com Battery did not match the OGORS. Oil was moved from the oil tank to the water tank while work was being done to repair the oil tank. When inventories were moved back, the inventory still did not match because free water was not subtracted from the total oil volume.

We were advised by ONRR to adjust the inventories to appropriately reflect what was out in the field using code 08 on the OGOR and pay the royalties for the difference.
