PU & RIH w/ 3-1/2 P-110 IPC-2000, CS-Hydrill Injection Tubing & set packer +/- 13,780' (5-1/2 csg shoe @ 13,823')

Circulate packer fluid.

Sting into packer and set in compression w/ 20 points.

RD BOP & land tbg

NU 5K well head

Run MIT test. (Give 24 hour notice to BLM & NMOCD prior to MIT test)

MIRU Acid truck and stimulate w/ 15,000 gal 28% HCl

RD PU

Remediate location.

Build tank facility.
