Drill 12-1/4" hole to 4314' (11/21/17). RIH w/ 9-5/8" 47# L80 BTC csg and set @ 4304', pump 40 BBLs gel spacer w/ green dye, then cmt w/ 1344 sks (395 BBLs) PPC w/ additives, 12.9 PPG, 1.73 yield, followed by 175 sks (40 BBLs) PPC w/ additives, 14.8 PPG, 1.33 yield. Circ 817 sks (170 BBLs) to surface, full returns during job, BLM present to witness cmt operations. Pressure test csg to 4760 psi for 30 min, good test. Install pack off, ND BOP, install well cap, and move off location.
