12/11/17 - Ran gyro survey from 2250 ft up to surface. Loaded and circulated with plugging mud.

Tagged CIBP. Pressure tested to 500 psi, held good.

12/12/17 - Spotted 50 sx Class C cement on top of CIBP from 2275 ft - 1555 ft calc TOC. WOC.

Tagged TOC at 1636 ft. ND BOP. Spotted 120 sx Class C cement from 997 ft up to surface. Topped off well with cement. NOTE: P&A witnessed by Robert Girndt with Carlsbad BLM.

12/14/17 - Cut off wellhead. Installed dry hole marker and cut off anchors. WELL IS PLUGGED AND ABANDONED.
