12/21/17 - Tagged TOC at 1567 ft. ND BOP. Broke circulation. Spotted 72 sx Class C cement from 1039 ft up to surface. Topped off well with cement.

1/3/18 - Cut off wellhead. Installed dry hole marker and cut off anchors. WELL IS PLUGGED AND ABANDONED.
