Spud 17-1/2" hole 12/21/17, drill to 720' 12/17/17. RIH & set 13-3/8" 54.5# J-55 BTC csg @ 720', pump 20 BBLs FW spacer then cmt w/ 895 sks (216 BBLs) PPC w/ additives, 14.8 PPG, 1.36 yield, circ 118 BBLs to surface. Notified Gabriel Beneway at BLM. 12/8/17 ND BOP, install well cap, release rig.

12/20/17 NU BOP, test @ 250 psi low, 5000 psi high, good test. Pressure test csg to 1500 psi for 30 min, good test. RIH & tag cmt @ 675', drill new formation to 730', perform FIT EMW = 17.6 PPG. Drill 12-1/4" hole to 4420' (12/22/17). RIH w/ 9-5/8" 47 PPG, L-80 BTC csg and set @ 4407', pump 30 BBLs gel spacer then cmt w/ 1105 sks (356 BBLs) PPC w/ additives, 12.9 PPG, 1.81 yield followed by 155 sks (37 BBLs) 14.8 PPG, 1.33 yield. Circ. 120 BBLs to surface. BLM rep Steve Zota on site to witness cmt job. Pressure test csg to 4800 psi for 30 min, good test. Install well cap and release rig (12/23/17).
