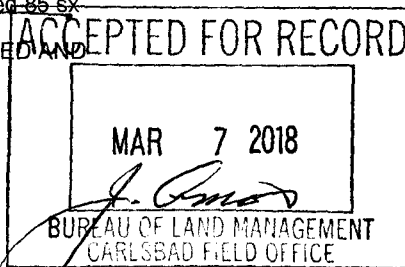
3/7/18 - Cut off wellhead. Installed dry hole marker and cut off anchors. WELL IS PLUGGED AND ABANDONED.
