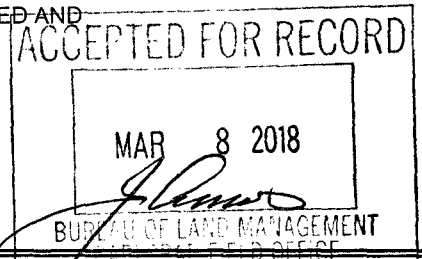
2/23/18 - Tagged CIBP. Circulated 40 bbls. Pressure tested to 500 psi for 30 min, held good.
