 3/27/18 - Tagged CIBP. Circulated 40 bbls water. Pressure tested to 500 psi for 30 min, held good. Spotted 125 sX Class C cement from 1246 ft up to surface. Topped off well with cement.
 3/29/18 - Cut off wellhead. Installed dry hole marker and cut off anchors. WELL IS PLUGGED AND ABANDONED.
