4/4/18 - Tagged CIBP. Circulated 40 bbls water. Pressure tested to 500 psi, held good. Spotted 125 sx Class C cement from 1236 ft up to surface. Topped off well with cement.

4/10/18 - Cut off wellhead. Installed dry hole marker and cut off anchors. WELL IS PLUGGED AND ABANDONED.
