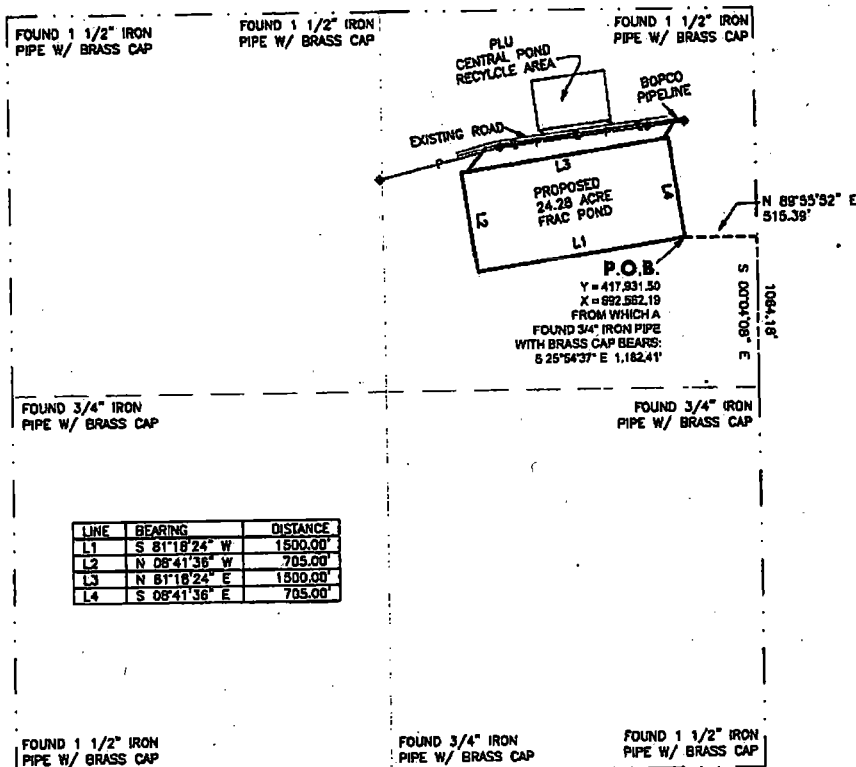

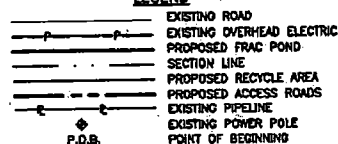
TOWNSHIP 25 SOUTH, RANGE 30 EAST

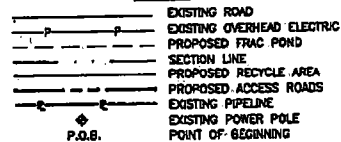
