Set 5-1/2" CBP @ 4320' & PT 5-1/2" csg & CBP to 4000 psi-OK. Perfed Yeso @ 3948'-4258' w/27 holes. Treated new Yeso perms w/1008 gal 15% HCL & fraced w/29,865# 100 mesh & 282,705# 30/50 sand in slick water. Spotted 500 gal 15% HCL across next stage.  
Set 5-1/2" CBP @ 3850' & PT 5-1/2" csg & CBP to 4000 psi-OK. Perfed Yeso @ 3490'-3761' w/32 holes. Treated new Yeso perms w/1500 gal 15% HCL & fraced w/30,040# 100 mesh & 241,064# 30/50 sand in slick water. Spotted 504 gal 15% HCL across next stage.
